HOW TO GET A DISPENSARY LICENSE IN ILLINOIS – 2025 GUIDE

This guide covers application requirements, license types, compliance standards, and strategic steps to help you open a legal cannabis dispensary in Illinois.



License Types in 2025

1. Conditional License

- Provisional license granted before securing a location
- · Must convert to full license within a set timeframe

2. Adult Use Dispensing Organization License

- Required to operate a recreational dispensary
- 3. Medical Cannabis Dispensary License
- Allows sales to registered patients
- · Can be held alongside an adult-use license
- 4. Other Licenses (Non-Retail)
- · Craft Grower, Infuser, Transporter: for vertically integrated operators

5. Who Can Apply?

- Must be 21 years or older
- Must pass a background check (no disqualifying felonies)
- Must register a legal entity (LLC, Corp, or Partnership)
- Entity must be registered with the Illinois Secretary of State

Application Process

Pre-Application Setup

- · Form your business entity and obtain an EIN
- Register with the Illinois Secretary of State
- Secure a property that meets zoning requirements

Prepare Documentation

- Business Plan: Include operations, market strategy, financials
- Security Plan: 24/7 surveillance, alarms, secure access
- Inventory Management Plan: Detail how you'll use Metro
- Diversity & Inclusion Plan: Required under Illinois law
- Labor Peace Agreement: Required for 10+ employees
- Zoning Compliance: Site approval from local authorities

Submit Application

- Upload all documents to the IDFPR licensing portal
- Pay non-refundable application fees

Cost Item	Standard Applicant	Social Equity Applicant
Application Fee	\$5,000	\$5,000
License Fee (2- year term)	\$60,000	\$30,000
Legal & Consulting Fees	\$10K-\$50K+	Varies
Buildout & Equipment	\$150K-\$500K+	Varies

Compliance Requirements

1. Seed-to-Sale Tracking

• Use Metrc for real-time inventory tracking

2. Security Standards

Secure storage, surveillance, and incident protocols

3. Labeling & Packaging

• Must be child-resistant, resealable, and clearly labeled

4. Age Verification

Sales only to customers 21+

5. Zoning Restrictions

• Must be at least 1,500 feet from other dispensaries and 1,000 feet from schools

6. Advertising Limits

Ads cannot target minors or be near public spaces

7. Regular Audits

Must reconcile inventory with Metrc frequently

Operating a Dispensary in Illinois

- Daily Operations
- Train staff on Metrc, ID checks, and emergency protocols
- Implement POS and inventory software (e.g., IndicaOnline)
- · Use secure ID scanning and enforce purchase limits
- Stock only state-licensed cannabis products
- Follow all local health regulations, including sanitation, PPE, and employee health standards
